



## 2019 WIOA Youth Services Question and Answer

**February 14, 2019**

**Q – Will the RSVPs for the Bidder’s Conference be posted beforehand?**

**A – No, however a list of those that attend the Bidders Conference will be posted after the meeting.**

**Bidder’s Conference February 21,2019**

**Q – Will the provisional contract award notification happen any sooner than May?**

**A – No. The provisional contract award can only be announced after the CWP Executive Committee approves or rejects the recommendation of the evaluation team. However, we may be able to let respondents know what the evaluation team is recommending.**

**Q – What was your vision for making sure equity was a strong component of the services that are provided for this award? How will one agency be able to address the multiple needs of the populations that need to be served under the WIOA Youth Services contract?**

**A – Respondents can design their own approach to ensure equity and inclusion that ensures underserved and prioritized populations will be served.**

**Q – Is CWP seeking a single provider for the WIOA funds, or is it possible to submit a proposal for a portion of the available funds – in other words is CWP seeking multiple providers?**

**A – CWP is seeking to make one award.**

**Q – Page 20 Program Cost reads “The expectation is that no less than 25% of funds be spent on work experience.” Is this an error because WIOA requires only 20%?**

**A – CWP requires 25%.**

**Q – Is it a conflict of interest to have a community reference who is a CWP board member or otherwise close to CWP?**

**A – No**

**Q – Is it acceptable to have a youth as a community reference?**

**A – Yes**

**Q – Are follow-up participants to be included in the Budget Summary on the Proposal Cover Page, page 13?**



**A – Yes, follow-up participants may be included in the number of participants to be served.**

**Q – Do the proposals and supporting documents need to be in separate sealed envelopes?**

**A – No, they can be in one envelope.**

**Q – What is the maximum number of pages allowed for the Program Design?**

**A – A maximum of 7 pages are allowed in the Program Design Section.**
